A new European safety standard

The new European standard EN 16005 sets out the design requirements and testing methods used to ensure the safe use of automatic doors. The new standard has created a Europe-wide safety standard for automatic doors.

EN 16005 has been valid in 33 European countries since April 2013.

In Germany, EN 16005 has been implemented in DIN EN 16005. At the moment, DIN 18650 is still the valid safety standard. The safety level of EN 16005 is comparable to the level of DIN 18650.

- ▶ safe distances to prevent crushing and being drawn in
- ▶ limitation of the leaf forces

and the requirement of a high safety level for the door control unit and sensors:

► "Performance Level c" for standard doors and "Performance Level d" for emergency exits respectively (according to EN ISO 13849-1)

A test log book and safety analyses for automatic sliding, swing and revolving doors from GEZE are available.
